

PROMOTION TERMS AND CONDITIONS

THESE ARE THE OFFICIAL PROMOTION TERMS AND CONDITIONS. PARTICIPATION IN THE PROMOTION CONSTITUTES ACCEPTANCE OF THESE PROMOTION TERMS AND CONDITIONS (THE "PROMOTION TERMS").

Definitions

BCLC:	British Columbia Lottery Corporation.
Promotion:	On Fridays during the Promotion Period Qualified Entrants may enter Mystery Seat Draws in order to win bonus slot play awarded as Encore Rewards Points.
Mystery Seat Draw Days:	Every Friday during the Promotion Period, and each Draw Day.
Mystery Seat Draw:	1:00 PM and 2:00 PM PT on each Draw Day.
Draw Prize:	There are two (2) Bonus Slot Play prizes available on each Draw Day for a total Draw Day prize value of three hundred dollars (CDN\$300) Bonus Slot Play to be awarded as sixty thousand (60,000) Encore Rewards Points. One (1) prize of one hundred and fifty (\$150CDN) Bonus Slot Play awarded as 30,000 Encore Rewards Points at each Draw Time.
Drawn Entrant:	Qualified Entrant whose name has been drawn, as a result of a Mystery Seat Draw.
Participating Facility:	Cascades Casino Delta, Delta BC
Gaming Day:	The 24-hour period starting from 7:00am PT to 6:59 am PT the following day during the Promotion Period
Gateway:	Gateway Casinos & Entertainment Limited
Qualified Entrant:	An individual who is 65 and years of age or older and an Encore Rewards member or an American resident, of the 50 United States excluding New York, Rhode Island, Florida and Texas, or a Canadian resident, and a valid Encore Rewards member, but does not include:

- Employees, agents, successors and assignees of Gateway, its advertising agencies and promotional companies involved in this Promotion (if any), as well as family and household members of same;
- Employees, agent's successor and assignees of BCLC or the participating gaming service provider and their family and household members who reside at the same address; or
- Individuals who have self-excluded or who self-exclude during the Promotion Period and individuals that are barred from a BCLC gaming facility.

Winner Authorization Form: Means such representations, indemnities and releases as Gateway may require in its sole discretion from a Drawn Entrant in consideration of and in order to induce Gateway to deliver a Draw Prize to the Drawn Entrant.

HOW TO ENTER and WIN a Draw Prize:

- 1 Encore Rewards membership is required to participate.
- 2 Qualified Entrants must visit Casino Guest Services and register for the Draw prior to Draw Time to qualify.
- 3 During the Promotion Period at the Participating Facility, a Qualified Entrant can enter into the Mystery Seat Draw by having his/her Encore card accepted into the card reader on any designated slot machine at the time of a scheduled Mystery Seat Draw (no purchase/play necessary).
- 4 Odds of winning a Draw Prize are based on the total number of Qualified Entrants having their Encore Rewards cards accepted into the card readers in the slot machines at the time of a scheduled Mystery Seat Draw.
- 5 The Mystery Seat Draw will be programmed as an Instant Hit promotion using the Power Winner's program available in the Bally Elite Bonusing Suite on each slot machine A-S-L at the Participating Facility.
- 6 At the Participating Facility, two (2) IGCO registered employees, under surveillance, will select Drawn Entrants manually using the Manual Winner Confirmation function in the Power Winner's program at each designated Draw Time. The IGCO registered employees will attempt to contact the Drawn Entrant by approach the Drawn Entrant seated at the chosen A-S-L in person on the gaming floor, verify their government issued photo ID and Encore Rewards Card and have them answer a skill testing question. Once the ID is verified and the skill testing question is answered correctly, the Drawn Entrant will be declared the winning Drawn Entrant.
- 7 If there is no one seated at the chosen slot machine A-S-L reasonable efforts shall be made to locate the Drawn Entrant. If the Drawn Entrant cannot be contacted within a reasonable time frame a public announcement of the unclaimed prize and the intention to redraw the Mystery Seat Draw shall be made prior to generating a new Drawn Entrant. The Drawn Entrant will have three (3) minutes to present

themselves to Guest Services following such announcement. If the Drawn Entrant does not present themselves within the allotted time, the two (2) IGCO registered employees will complete another Manual Winner Confirmation to select another Drawn Entrant. The process will be repeated until a present Drawn Entrant is found.

- 8 If a Drawn Entrant claims a Draw Prize after a new Drawn Entrant selection has been made, the original Drawn Entrant's claim shall be denied and an Incident Report shall be created. In the event of any dispute arising out of any aspect of the Mystery Seat Draw, the two (2) IGCO registered employees shall make the final and binding determination.
- 9 The Drawn Entrant will be required to present valid government issued photo identification, answer a skill testing question and complete a Winner's Authorization Form in the presence of two (2) registered gaming employees, before the Draw Prize can be released. At such time, the two (2) registered gaming employees will record the completed Mystery Seat Draw on a printed tracking form and sign their names and IGCO numbers.
- 10 All Draw Prizes will be manually paid out as Encore Rewards points by a Guest Services Supervisor.
- 11 The Surveillance Department will record each Mystery Seat Draw and will hold the footage in its entirety for thirty (30) days.
- 12 Each Qualified Entrant may win more than one (1) Draw Prize, but only one Draw Prize per day at the Participating Site.
