Definitions

1. There will be a maximum number of thirty-two sessions in the first round of the tournament with up to twelve (12) Qualified Entrants participating in each session. A maximum total of three hundred eighty-four (384) Qualified Entrants will be able to participate in the first round on each Qualifying Tournament Day.
2. Qualified Entrants must pre-register for the Tournament by providing their name, government issued photo ID and Encore Rewards number or for a non-Encore Rewards member their name, government issued photo ID, and phone number to a Guest Services Representative during the Registration Period.
